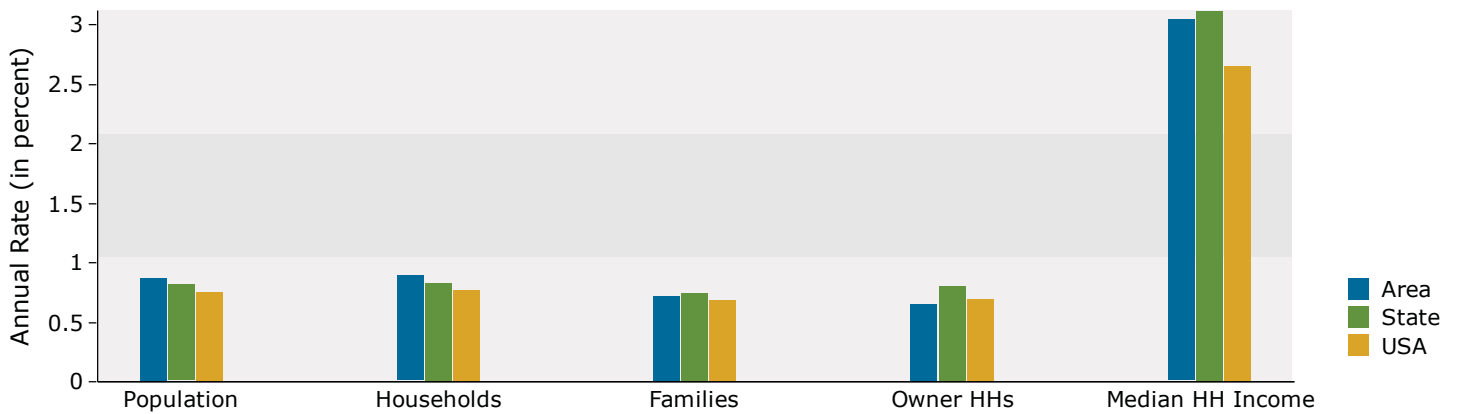

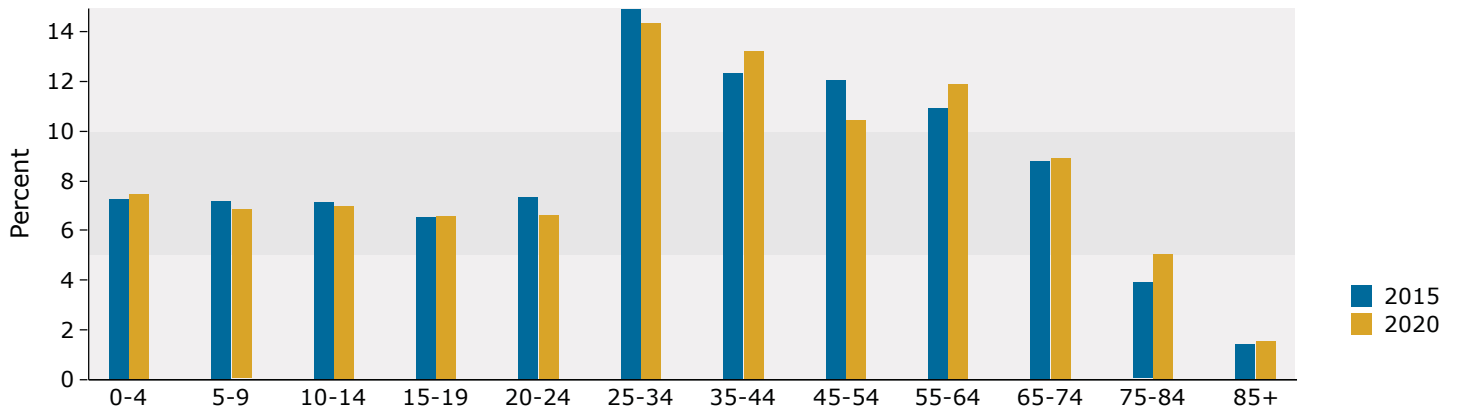

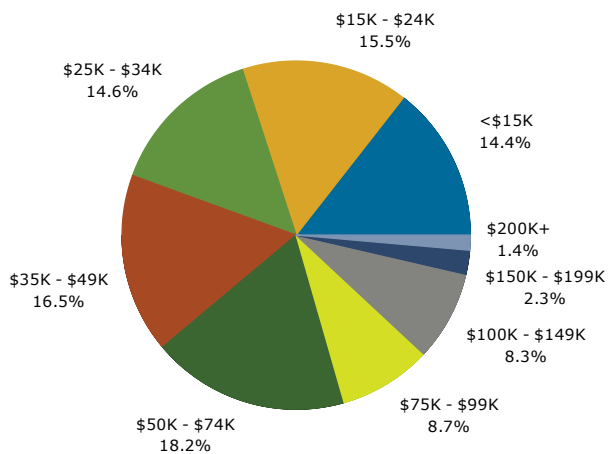
Trends 2015-2020



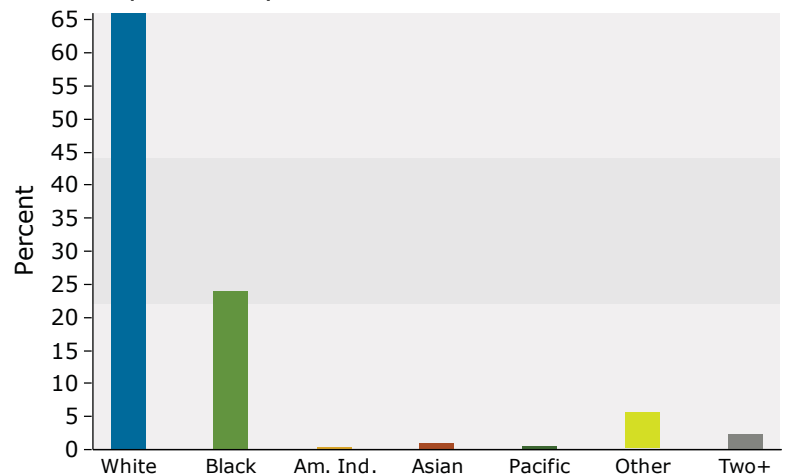
Population by Age

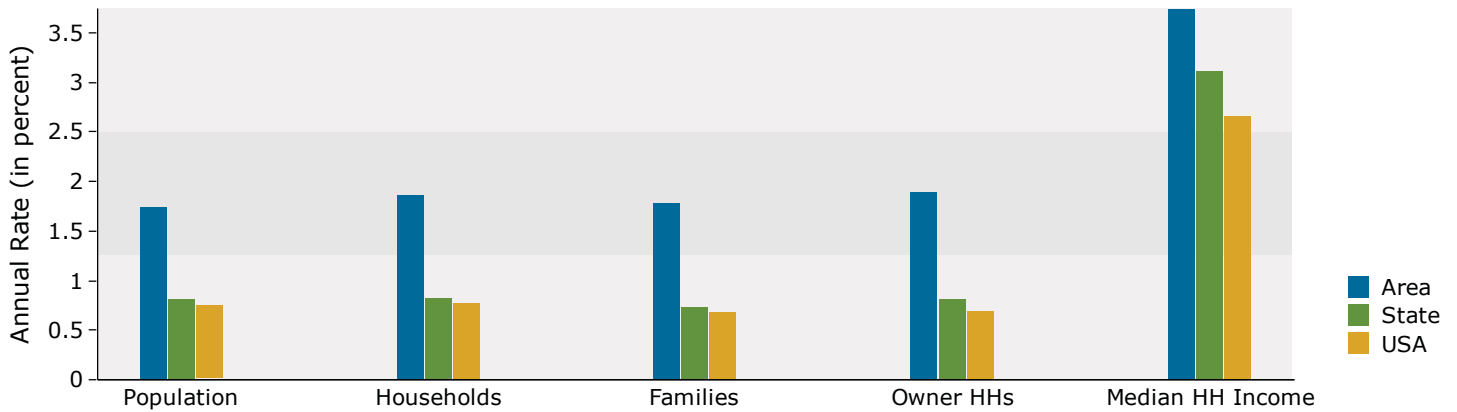

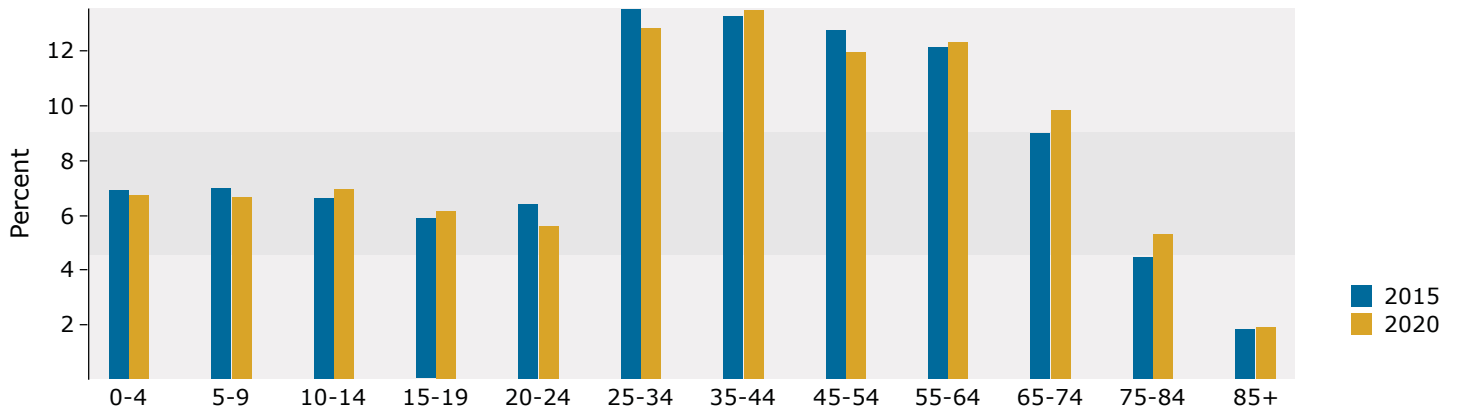

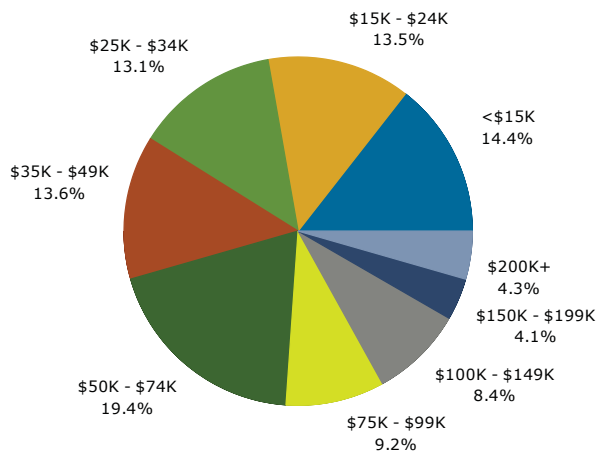
Trends 2015-2020



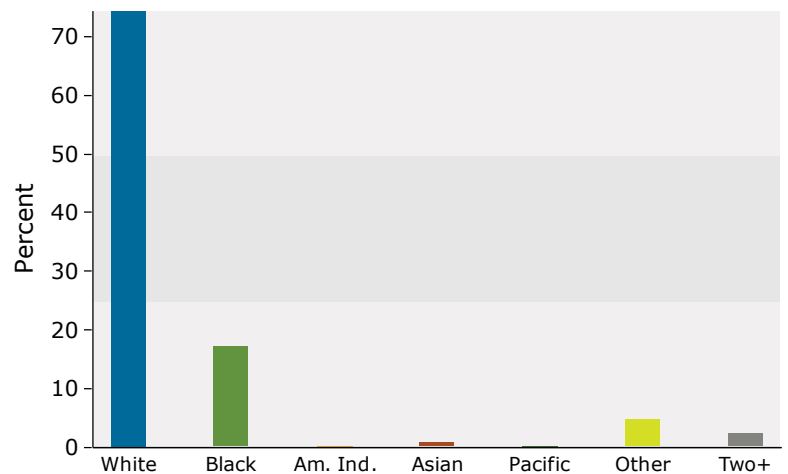
Population by Age

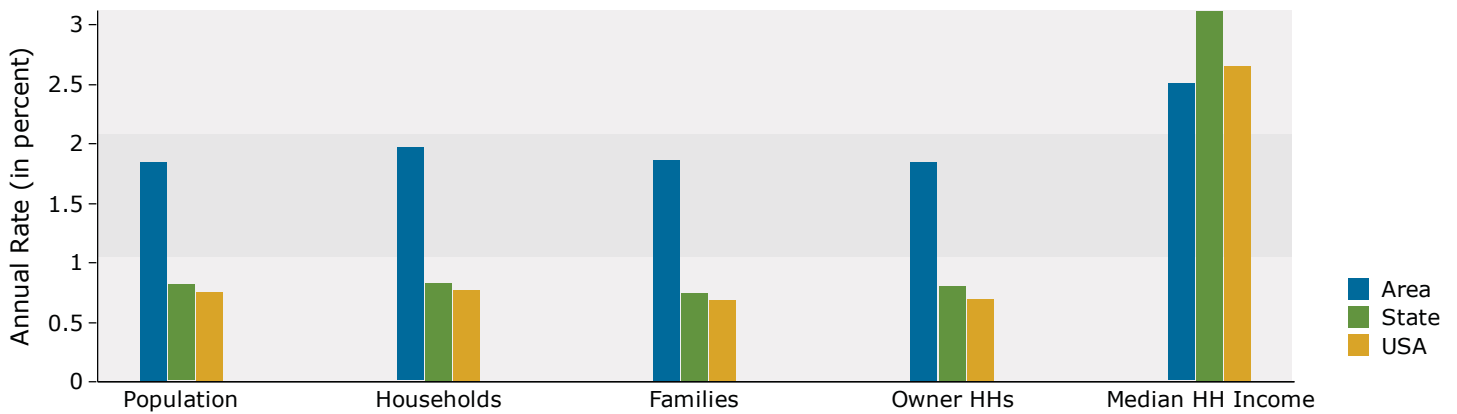

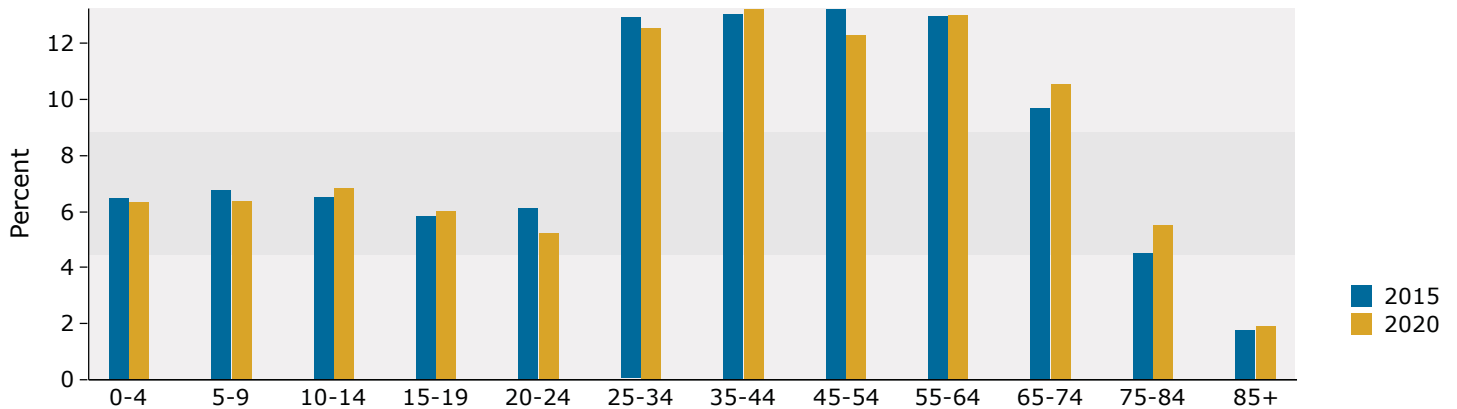

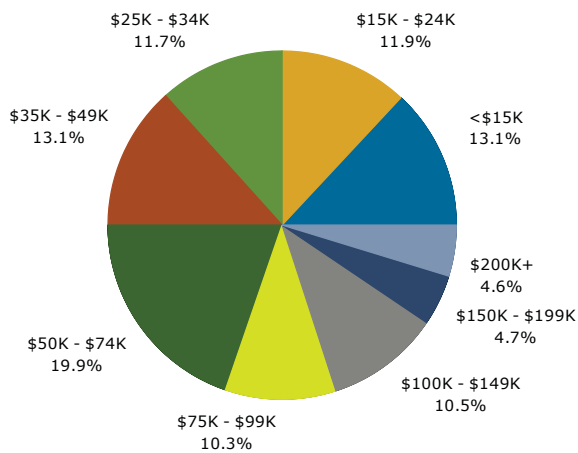
Trends 2015-2020



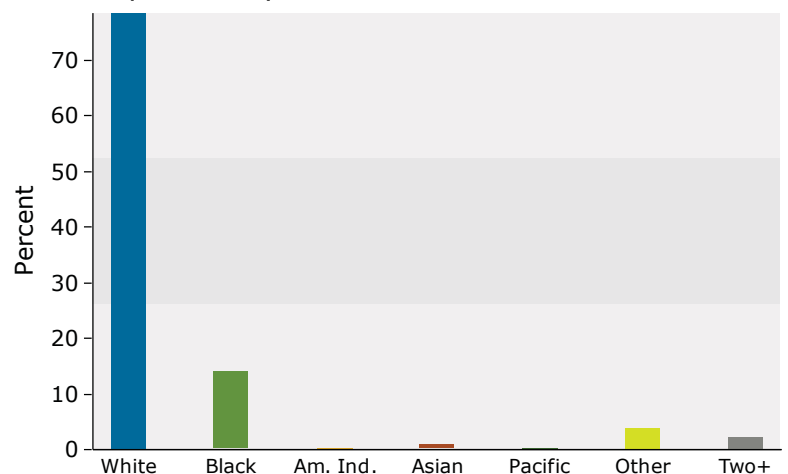
Population by Age
